Foreword

Not-for-Profits

This year marks the 9th iteration of 2into3's *Irish Not-for-Profit Sector: Fundraising Performance Report*. The report maps trends across the sector, using a representative sample of not-for-profit organisations to chart philanthropic income trends in Ireland year-on-year, providing insight into their activities and experiences, particularly those concerning fundraising.

Charitable giving in Ireland is a substantial source of income, rising for the eighth consecutive year in 2017. Despite this, Ireland continually lags the UK in per capita giving and in giving as a percentage of GDP, a trend captured over the last five years (2into3, 2014 -2018). This is even as the UK's per capita giving falls for the first time since 2into3 began tracking this figure in 2014. This report compares Ireland's giving culture to that of the U.K. and U.S., exploring factors contributing to the disparity, including the tax treatment of charitable giving in Ireland after the 2013 changes to the code, a discussion to which BDO has contributed this year.

The report estimates the total amount of fundraised income in Ireland in 2017 and includes the funding model of the sector and of each subsector. This year, funding models have been expanded to reflect investment and sponsorship income in addition to state, earned and fundraised income. We hope to further disaggregate sources of income in future reports as the quality of data available improves. Also considered is the continuously evolving size of the sector, in light of the Charities Regulator's registered list of charities and the Benefacts database, which provides a strong foundation from which research on the sector can grow.

We aim, as always with this report, to stimulate debate, discussion, and reflection, while motivating civic and private stakeholders to support the efforts of the sector in continuing to enhance fundraising performance.

Introduction

Life in Ireland hinges on the not-for-profit sector, as the sector reflects the values and ideals of the thousands of people who form its fabric as staff, volunteers and beneficiaries. The countless hours devoted by staff and volunteers and millions of euro donated to Ireland's more than 20,000 not-for-profit organisations serve to illustrate this.

The functions served by the sector appear endless; not-for-profit organisations deliver indispensable health and social services to the public, educate our young and not so young, provide housing and give people a voice through advocacy. These organisations work tirelessly to conserve, beautify and protect the things we hold dear, engaging with individuals and families every day and forming a vital and core facet of society.

Despite the central role the sector plays in our lives, solid, systematic research remains scarce, putting Irish not-for-profit sector's ability to perform at capacity at risk. In the absence of information reported by the sector, efforts to regain public trust and move forward are stifled. Without this data, policymakers cannot make truly informed decisions, nor can CEOs and fundraising managers benefit from knowledge sharing and best practice of other organisations.

Though discussions surrounding increased accountability and transparency are ongoing, the need for a standardised, evidence-based approach to substantiate strategical developments and deepen analysis of the sector remains.

As it enters its 9th year, this report seeks to narrow the knowledge gap by providing insight into the not-for-profit sector's composition and overall status in 2017, particularly in terms of philanthropic activity, performance and cost. We aim to provide objective information that will provide a platform for organisations to come together to debate and discuss solutions that will elevate the sector as a whole.

The regulation of the not-for-profit sector has evolved significantly since the establishment of the Charities Regulator in 2014 under the Charities Act 2009. The Regulator promotes accountability by maintaining a public register of charitable organisations in Ireland and ensuring their compliance with the Charities Act. In 2017, the Register of Charities had 9,061 charitable organisations, adding 1,757 during the year, an increase of 22% and a significant acceleration in growth (Charities Regulator, 2017).

Under the Charities Act 2009, use of Charities SORP (Statement of Recommended Practice) is intended to become mandatory in Ireland, though this has not yet happened. At present, organisations with charitable status are expected to adhere to the Guidelines for Charitable Organisations on Fundraising from the Public and the Governance Code for the Community and Voluntary Sector. This year, however, the Charities Regulator published the Charities Governance Code, which sets out minimum standards and best practice for charities to abide by and aims to support trustees in upholding good governance (Charities Regulator, 2019). With 2019 as a year of learning and preparation for charities, 2020 will be the first year that charities are expected to comply with the code and in 2021 they will be required to report on their compliance. While the code calls on charities to produce full financial accounts and make annual reports widely available and accessible to the public, this is an additional standard and not a core requirement. It then falls to the Companies Registration Office to bring about more transparent reporting standards. However, with changes to the Companies Act in 2017 which raised the threshold for filing abridged accounts, the responsibility of companies to publicly share accounts was significantly reduced, effectively moving transparency in the opposite direction.

Benefacts cites that 38% of all charities and 48% of the sector overall filed abridged accounts in 2017, tracking a dramatic incline over a three-year period in its news piece, 'Less doesn't always equal more in non-profit disclosure' (2019). This, according to Benefacts' Patricia Quinn, is a regulatory paradox, wherein government funders require charities to submit detailed accounts with no stipulation that they be shared with the public (2018). While charities are overly burdened by reporting and compliance from multiple funders, adopting the 'triple lock' standards of transparent reporting, good fundraising and governance is key to building and retaining public trust.

Knowledge on the size of the sector is now more in-depth as a result of the Charities Regulator list of registered charities and the Benefacts database. The sample selected for this report is based on the adjusted classification and size of the sector as per Benefacts. This report is therefore not directly comparable to previous reports in this series.

In this study, a process of **stratified random sampling** is used to depict the not-forprofit landscape in Ireland. This involves splitting the population of organisations into subsectors and taking a separate random sample from each of the subsector rather than a single random sample from the entire population. When extrapolated, the relative size of each subsector is the same in both the sample and the population. Stratified sampling offers several advantages over simple random sampling, specifically it:

- Provides greater precision than a simple random sample of the same size
- Guards against an "unrepresentative" sample
- Provides sufficient sample sizes to support separate analyses of each subsector
- Ensures better coverage of the population than simple random sampling

A database provided by Benefacts was used when randomly selecting the total population by subsector, determining how many organisations from each category should be included in the sample. Once the population was split into its component strata, listed organisations were systematically selected for inclusion in the sample with abridged accounts excluded. Organisations selected were then checked for available financial information and obtained from the Benefacts database.

A sample of 10% of organisations was used for subsectors with a sufficient number of available accounts. In the remaining sectors, a sample of 5% or 3% was used. The total sample size then equates to **1,304 organisations or 6.4% of the total not-for-profit sector**. The sample used in this report, when extrapolated, mirrors the proportional representation of the not-for-profit sector.

Extracting key data on fundraised income and cost is still very challenging. Annual accounts were not compiled with the intention of inclusion in this report's analysis, and in many cases very limited information on fundraising is provided. While organisations are increasingly including fundraised income as a line item in accounts under 'donations', many organisations present income in a more aggregate format or combine sources of funding (e.g. 'income from Events and Corporate Donations') or subsume fundraised income under another heading.

To provide more detailed information on fundraising mix and cost, a second smaller sample of 24 organisations is included. These organisations responded to a survey and are anonymous. Unless explicitly stated otherwise, the figures presented in the report are from the main sample.

Filing of abridged accounts increased to 48%, almost doubling since 2015 and 10% year-on-year.

Despite continued calls for increased accountability in the sector, the filing of abridged accounts has increased exponentially, from 27% in 2015 to 38% in 2016 and 48% in 2017 (Benefacts, 2019). Of these organisations, Recreation & Sport and Local Development & Housing led in the filing of abridged accounts. Alternately, the International and Health sectors led in SORP compliance. Overall **only 6% of organisations reported to SORP standards according to Benefacts.**



Sample Overview

The not-for-profit sector comprises 12 subsectors, as identified by Benefacts. The sample used in this report mirrors the proportional representation of the sector by applying the **stratified random sampling** technique in the selection of organisations and extrapolating to reflect the relative size of each subsector.

As outlined below, **Education continues to dominate the sector, accounting for a quarter of all not-for-profit organisations in Ireland**, followed by Recreation & Sport and Local Development & Housing, each accounting for 16% of the population. The remaining subsectors are made up of smaller numbers of organisations.





Income



Education & Research dominates in both size and income. Health is small in size but significant in income.

Education & Research dominates the sector, accounting for 25% of the total population and 34% of total income. Health represents a small proportion of organisations present within the sector, accounting for 4% of the entire population. However, Health organisations make up 8% of the sector's income.






Recreation & Sport represents 16% of the population but only 11% of total income. **Education & Research, Health and Recreation & Sport all present variances between income and size.** Advocacy, Law & Politics and Professional & Vocational in particular have the closest relationship between income and size.



Transforming Not-for-Profits Over half of organisations have income less than €250,000.

57% of organisations had an income below €250,000 with almost 30% reporting income below €50,000. As seen in Figure 5, only 15% of organisations had income of €1,000,000 or more, and 2% reported an income of €10,000,000 or more. The sector remains particularly bottom-heavy, with many organisations 'relying largely or exclusively on voluntary effort' due to low financial turnover (Benefacts, 2019).

The average income for organisations in 2017 was €1,190,953 with **13% of organisations reported an income above the average figure. The median, however, was far lower, at €174,898**, indicating that a number of large organisations inflated the average income level, a trend seen throughout this report series. There continues to be a significant disparity between the lowest and highest income brackets within the not-for-profit sector, with both particularly small and very large organisations appearing in this sample.



The total income of the not-for-profit sector is difficult to estimate, particularly in light of the dramatic increase in abridged accounts across the sector and across income brackets. Benefacts cite that the total income figure of the sector of which data is available totalled €13.8 billion in 2017, an increase from €12.1 billion in 2016.






Fundraising accounted for 8% of the sector's funding model.


Income in the not-for-profit sector is categorised into three main sources: state, earned and fundraised income, while this year the report further disaggregates income to include investment and sponsorship income. This funding model, however, is subject to great variation when broken down by subsector as well as by organisation size. The funding model for the sector is presented in Figure 6. State funding formed the majority source of income at 60%, while fundraised income accounted for 8%. Earned income, composed of activities such as ticket sales and rental income, generated 28% of total income. While investment and sponsorship income did not form a significant portion of income for the overall sector, they are more prominent sources when broken down by subsector.



Funding varies greatly on a subsectoral level, . Social Services and Health organisations deliver a wide variety of services for the state, receiving 73% and 76% of their funding from this source, respectively. For Professional & Vocational organisations, 77% of income was earned. The Philanthropy & Voluntarism sector, which includes foundations, received the majority of its income from fundraising, which comprised 74% of its funding model. Religious organisations were similar, sourcing 90% of their income from fundraising, relying more heavily on investment income (5%) than the state (less than 1%) for income. Philanthropy & Voluntarism as well as Professional & Vocational and Environment had investment income in their funding models, while Recreation & Sport reported 4% of income come from sponsorship.

The funding models for each subsector can be found on pages 8-10. Below, subsectors are grouped based on their dominant source of funding. Recreation & Sport's income was split almost evenly between State and Earned income, hence its placement between the two sources.






Funding Model by Subsector







State Income




State Income accounted for 60% of total income, increasing 8% from 2016.

In 2017, state income accounted for 60% of total income, indicating a continued reliance on not-for-profit organisations by the state to deliver vital services to the public. This is particularly evident for Social Services and Health organisations, which receive proportionally more state income than other subsectors, while Religion received the smallest state contribution.

In 2017, state income increased 8% year-on-year, while greater variances are seen in subsectoral trends, with all 12 subsectors reporting increased state funding. Philanthropy & Voluntarism saw the largest rise in statutory income at 22%, followed by Environment, which reported a 15% increase. Proportionally, Environment continues to rely more heavily on fundraising.

Government was the biggest single source of funding in 2017 at €5.9 bn, accounting for 8.4% of Government expenditure that year (Benefacts, 2018). This accompanies the shift in the nature of state funding from grant-making to a commissioning model, marking a changing relationship between the state and the sector. While this has contributed to the professionalisation of the sector, the increasing compliance demands of the State as a primary poses significant challenges for many organisations. In 2017, the Department of Public Expenditure and Reform drafted a definition of commissioning and guiding principles on its approach and reported its intention to align and integrate this approach with existing expenditure policy (DPER, 2017).


Staffing levels increased by 2%, while nearly half of organisations employ 5 staff or less.


49% of organisations employed 5 or less staff in 2017, as outlined in the chart below. Organisations with more than 50 members of staff totalled 8%. Of organisations in the sample, 4% had more than 100 staff.

Disparity in the sector was also found with regards to staffing levels. On average, **organisations employed 25 staff members, over four times the median of 6**. 82% of organisations had staff levels below the identified average.


Figure 9: Distribution of Organisations by Staff Number, 2017

As seen in Figure 10, over half of organisations experienced no change in staff numbers between 2016 and 2017. Almost a third of organisations added to their teams, resulting in a 2% increase overall.



Education & Research organisations received 22c of every €1 raised in Ireland in 2017.

Ireland has historically been viewed as having a highly generous population, consistently ranking highly in the World Giving Index. In 2017, **Ireland ranked 5th most generous nation, ahead of the UK, which placed 6th.** These results reflected the number of respondents who reporting having volunteered, helped a stranger or given money to charity in the last 30 days. However, when ranked by charitable giving alone, Ireland, while remaining in the top 10, dropped one position, ranking 9th (CAF World Giving Index, 2018). Furthermore, while Ireland is more generous by frequency, the U.K., whose philanthropic infrastructure is more developed, gives greater amounts. This is attributable to the U.K. having a better tax policy for incentivising giving, a more established culture of legacy giving, as well as the higher number of trusts and foundations in the U.K. Ireland has just 40 trusts and foundations on record, a fraction of that of the U.K (Johnson, 2018).

As stated in the methodology, almost half of accounts in 2017 were abridged, with reported income more often than not provided in aggregate. The result is that fundraised income and its sources continue to be significantly underreported. Only a small number of organisations in our sample provided additional information. It is on this small group that this analysis is carried out. As such, the results are no longer necessarily representative of the experiences of the entire sector.

As illustrated in Figure 11, Education & Research received 22c of every €1 raised in 2017, while Philanthropic organisations received 18c of every €1. Environment and Sporting organisations contributed 2% of total fundraised income each, while Professional & Vocational, received 1%.

Fundraised Income

Transforming Fundraised income by method is consistently underreported.

The not-for-profit sector relies on a variety of fundraising methods, from Corporate Donations to Selling Something and Legacy giving. As equally varied are the skills, time commitment and investment required to implement each method. Each organisation must identify the range of fundraising techniques that are best aligned to their funding targets and resources, measured in terms of overall income. The fundraising mix is influenced both by subsector and an organisation's purpose.

For the 417 organisations with available data, a total of 677 observations on fundraised income by method were found, with fewer organisations reporting fundraised income despite an increased sample size due to the growth of the sector. Most frequently cited were 'donations', which accounted for 37% of all observations, with organisations frequently using this as an amalgamation of various fundraising methods. Likewise, many organisations included 'fundraised' income but did not specify further.

While others provided detail on methods used, they combined income from more than one source, (e.g. Campaigns and Events), preventing the disaggregation of income by method. This unspecified fundraised income accounted for 26% of reporting. There was a high level of observations for Trusts and Foundation income, at 13%. Organisations typically named the Trust or Foundation or were more explicit when reporting on this form of income.

While annual accounts provide detail on fundraised income totals, there is a lack of available information to identify the fundraising mix of the sector using this approach, due to inconsistencies and underreporting. For the more developed organisations that do share their fundraising data, the absence of a common standard of reporting makes it difficult to draw meaningful analysis from what is available, highlighting the need for common definitions of charitable giving to be agreed upon (Hoolwerf, 2019).

Relationship fundraising forms the majority of fundraised income.

A survey of 24 organisations was conducted to provide a more detailed analysis of the fundraising mix. Figure 13 illustrates the fundraising mix of the sector from self-reporting compared to what can be derived from annual accounts.

Regular Giving (30%) and Direct Marketing Appeals (20%) dominate the fundraising mix, while income from Trusts & Foundations represented only 1% of fundraising, consistent with Ireland having the fewest charitable Trusts and Foundations in Europe (Johnson 2018). More traditional fundraising methods such as Local/Community Fundraising and Selling Something in reality represent a far smaller portion of fundraised income, at 9% and 6% respectively. Relationship-based methods formed 53% of all fundraised income.

Legacy giving forms a significant portion of the overall fundraising mix at 12%, with substantial growth year-on-year, suggesting a gravitation in the sector toward more transformative methods of giving, particularly for those organisations in the higher income brackets who may be repositioning themselves to take a long view of giving pathways. This comes at a time where a period of unprecedented intergenerational transfer of wealth is expected to occur between 2017 and 2036 in Ireland (The Community Foundation, 2018).


The formation of Benefacts has enabled Ireland to narrow the knowledge gap surrounding the voluntary sector. However, sectoral knowledge on the fundraising landscape remains incomplete due to inconsistent and incomplete reporting. The 2017 Critical Fundraising Report called for more evidence-informed fundraising decision making process that included participation in benchmarking to share information regarding and insights on fundraising performance (Murphy). Likewise, the European Fundraising Association (EFA) calls for increased collaboration and a unified approach to share and build knowledge among not-for-profits, advocating for not-for-profits to step beyond the interests and goals of the organisation only by sharing relevant data with umbrella bodies and researchers to form a more complete picture (Hoolwerf, 2019).

Ireland and the U.K. received a similar proportion of income from legacies.

Individual Donations dominated the U.S. fundraising mix, with Giving USA 2018 reporting \$286.5 billion worth of individual donations in 2017 and foundation giving reaching \$69.9 billion, up 15.5%. This is attributable to extremely significant gifts made to some of the country's largest foundations.

Individual donations in the U.K. totalled £13 billion in 2017, with legacy income at £2.7 billion (Pharaoh et al., 2018). The U.K., unlike Ireland, also uses Gift Aid, which incentivises both the charity and donor while allowing smaller organisations access to the scheme by extending the benefit to small donations.







Figure 15: UK Fundraised Income by Method 2017, NCVO 2019

When compared to Figure 15, similarities between the Irish fundraising mix and that of the U.S. and U.K. emerge, with a majority of the mix being individual donations and a significant proportion of legacy income However, with 16% of fundraised income the U.S. and U.K received through Foundations and only 1% being attributed to this method in Ireland, it is clear that Ireland's giving culture remains underdeveloped when compared internationally.

Fundraising Trends

In 2017, fundraised income experienced an average increase of 9%, showing a significant acceleration of growth. As outlined in the summary statistics table, organisational and subsectoral differences vary greatly. A nearly even split was found between organisations experiencing an increase or decrease in fundraised income, with 7 subsectors experiencing an uptake. The average monetary increase, however, is more than twice the average decrease, resulting in an overall upward trend.

Figure 17 shows that it was the ≤ 1 million to ≤ 5 million fundraised income bracket that experienced the most significant growth, rather than the over ≤ 5 million bracket, indicating a period of growth for middle-large organisations. Figure 18 shows Health as having the largest average increase of $\leq 160,964$ per organisation, while the largest average decrease was experienced by Philanthropy & Voluntarism. Local Development & Housing's 121.5% increase is directly attributable to a once-off donation to one organisation, without which fundraised income increases by 2%.

Despite the degree of acceleration in fundraised income year-on-year, trust and transparency remain a lasting issue for the sector, with just 12% of respondents reporting feeling that Irish charities were doing enough to build trust with their donors in a 2019 survey by Amárach. However, Amárach points out that while Irish charities are faced with a 'guilty until proven innocent' mentality by the public, giving remains a 'part of the Irish psyche'. With 67% of respondents desiring to hear more from charities about how their donations are used, improving donor communication and sharing data is key to winning back public trust in a competitive philanthropic space.

Expenses related to fundraising are continually and significantly underreported, making it difficult to construct a detailed breakdown of fundraising costs using the main cohort of organisations. The sector recognises that increased transparency is essential to regaining public trust. Despite being outwardly accepting of the need for regulation, however, organisations remain hesitant in reporting on administrative, overhead, and fundraising costs. This is compounded by a lack of public understanding of the economic reality of operating an organisation at a professional standard, a perception akin to the GAA, as charities are expected to be professional yet amateur at the same time (Amárach, 2019).

Though 71% of respondents said charities should hire the best professionals, 45% thought wages to be too high in 2019, though this is down from 51% in 2015 (Amárach). This contradiction threatens the ability of the sector to perform and to deliver high quality services. While keeping costs low is important, overheads are a reality that need to be acknowledged both by funders and public donors. There is a cost to professionalisation; attracting, retaining and training these professionals is essential to creating a sustainable and effective sector (Amárach, 2017: 31).

The public desire for charities to be 'run by volunteers and without overheads' while operating optimally and delivering top-quality services is simply not possible (Amárach, 2017: 17). In reality, organisations cannot truly build capacity or meet their potential in the absence of funding allocations for staff costs and overheads. In light of this ongoing struggle for the sector, organisations must challenge unfair criticisms and continue to advocate for the investment and funding they need to perform.

More practical limitations of the summary 'cost to raise a euro' measure include:

- Poor quality data is available from annual accounts
- Organisational fundraising outcomes are not explicitly fundraising activities i.e. media based raising awareness
- Large annual fluctuations of fundraised income and investment results in figures that may not be representative of an organisation's actual position
- Fundraising costs are correlated with a range of organisational characteristics including size, cause, capacity and age

In 2017, 20 organisations gave detailed information on their cost to raise €1, allowing 2into3 to estimate the costs associated with the various fundraising methods.

While the portion of organisations providing detailed information on fundraising costs is low, it still allows 2into3 to provide a reasonable depiction of the sector's experiences. Even so, this cost is an estimate based on a small, non-random sample and should therefore be viewed with caution.




Fundraising Costs

The cost of fundraising varies across different techniques, and in 2017 the average cost to raise €1 was 24c. Selling Something was the most costly method requiring 94c to raise €1. Notable in 2017 was the level of investment placed into Corporate Donations, at 35c to the Euro, especially considering the focus on Corporate Social Responsibility by the sector that year.

As previously outlined, the fundraising landscape in Ireland differs to that of the U.K. These differences are even more apparent when compared to the U.S. Therefore, while international costs of fundraising are illustrated below, the fundraising landscape and therefore the related costs are not directly comparable with Ireland.

Transforming Ireland lags significantly when compared internationally despite narrowing the gap in per capita giving between Ireland and the U.K.

The extrapolated sample of this report is representative of the not-for-profit sector in 2017, and can, therefore, depict the overall sectoral experience. In our effort to ensure the best representation of the sector, the top 1.5% of this cohort was removed from the extrapolation. Figures presented in this part of the report should be viewed with some caution due to underreporting and a lack of information particularly surrounding this form of income. With these caveats in place, it is estimated that in 2017, fundraised income for the Irish not-for-profit sector totalled ≤ 1.1 billion.

Ireland's fundraised income formed 0.30% of Irish GDP in 2017, with a **per capita rate of giving of €233, €125 lower than that of the U.K.** While there was an increase in giving in the U.K. in 2017, this was attributed to fewer people giving more (CAF UK Giving, 2018). Though income rose, 2017 saw growth in the U.K. voluntary sector slow, with public donations dipping for the first time in 8 years; the overall figure was bolstered by grants and investments (NCVO, 2019).

Comparisons in giving can be drawn between Ireland New Zealand due to the similarity in population and GDP. New Zealand's most recent data is from 2014 but shows per capita giving at €386 with an estimated total of €1.74 billion in philanthropic giving, significantly higher than that of Ireland in 2017. New Zealand has a highly developed culture of strategic giving, with voluntary and statutory trusts and foundations accounting for 42% of total giving (Cox, 2014: ii). Similarly, it was found that Norway, one of Ireland's closer European counterparts in terms of population and GDP, gave less per capita at €180 but gave more strategically, with 41% of giving coming through trusts and foundations (Sivesind, 2018).


A large-scale longitudinal study covering 20 European countries published by The European Research Network on Philanthropy highlights shortcomings in Ireland's reporting on giving, noting a very low-bound estimate and overall low availability of data (ERNOP, 2018).

Per capita, Ireland gives most to Educational and Philanthropic Not-for-Profits organisations.

> Per capita, Ireland gave €233 in 2017. Subsectoral differences have been identified when it comes to per capita giving levels, as Figure 19 illustrates. Education received the highest per capita contribution at €50.18, followed by Philanthropy at €43.01, despite a decrease in fundraised income year on year for each subsector and marking a reduction in religious giving, which had previously received the most donations per capita (2into3, 2017-2018). Professional & Vocational received the lowest donations per capita at €3.42, followed by Environment at €3.51.

> When extrapolated to depict overall sectoral experience, fundraised income increased in 2017 yielding €1.1 billion compared to €1 billion raised in 2016. Per capita giving increased by €21, to €233. However, giving as a percent of GDP fell from 0.33% to 0.30% year on year and for the third year recorded by 2into3 (2017-2018). This is attributable to the growth and recovery of the Irish economy.




Figure 20: Per Capita Giving by Subsector, 2017



Ireland's current tax regime is not conducive to encouraging high levels of philanthropic and charitable giving.

During 2018, Philanthropy Ireland engaged BDO to examine the impact of the 2013 change in the tax treatment of charitable donations and to consider the impact these changes have had on donor behaviour and on the value of donations made to eligible charities in Ireland.

The rationale for making the changes at the time was to simplify the administration of the tax scheme, which in turn could help to stimulate and increase the level of charitable and philanthropic giving.

Despite concerns raised prior to the changes, one of the key changes made in 2013 was the removal of the tax benefit from self-assessed donors. Prior to this, a self-assessed donor could claim a reduction in their tax liability for donations made to eligible charities at the rate of tax being paid by that individual i.e. 20% or 40%.

For tax purposes, PAYE and self-assessed donors, are now treated the same, with the charity benefiting from the tax relief in the form of a grossed-up payment at 31%. In this regard, Ireland is unique when benchmarked against other developed economies in that there is no personal benefit available on individual donations.

The tax changes enacted since 2013 have not been effective in stimulating or increasing the level of charitable and philanthropic giving in Ireland. In reality, the overall value of donations has decreased by approximately 24% comparing 2010 and 2016.

Efforts to simplify the process have not led to any meaningful increase in the number of not-for-profit entities or charities availing of the scheme. Of the 7,100 not-for-profits registered with the Revenue Commissions for the purposes of Charitable Tax Exemption, only 1 in 3, of these are eligible to avail of S.848 (A) tax relief with only 1,707 making a claim in 2016. This narrow eligibility puts Ireland at odds with many other countries with developed charitable sectors.

Most donations tend to be low in value with approximately 60% of donations being made by PAYE workers. The current scheme therefore has not been effective in mobilising large scale philanthropic giving, as the vast majority of amounts given are characterised as small charitable donations. BDO found that 90% of donations are below €1,000 in value.

The actual value of donations has decreased by almost a quarter when figures for 2010 and 2016 are compared, down from €119.7m to €92.4m.

In monetary terms a significant amount of donations (to the value of €8m) are not being refunded to charities. Approximately 87% of claims filed by charities are subject to some form of restriction. This level of restriction would suggest that the scheme is not working as effectively as desired.

Ireland is one of a very limited number of developed economies that applies a minimum donation amount (€250) to qualify for relief. Such an approach means there is no tax incentive to donors giving in smaller amounts. This is particularly relevant when discussing incentivising and earning a culture of giving in younger or first donors.

Ireland is also one of a few countries that implement a value cap on qualifying donations. Internationally, most countries cap the level of relief available on tax, generally as a percentage of an individual's tax bill or taxable income.

As can be seen from the table, Ireland is the only one of the three countries that does not provide a tax benefit directly to the donor. The UK use tax deductions, reducing taxable income by the value of the gift, as well as a grossed-up incentive under its Gift Aid scheme. New Zealand uses tax credits, therefore reducing your tax liability.

Ireland has a higher minimum donation, €250, to qualify for tax relief than New Zealand, \$5, and the UK which has no minimum threshold.

Ireland is one of the few countries that implement a value cap on qualifying donations. Internationally, the majority of countries cap the level of relief available on tax generally as a percentage of either your tax bill or taxable income as is the case in the UK and New Zealand.

Conclusion



This report seeks to provide an overview of the status of the Irish-not-for-profit sector in 2017 in response to an ongoing need for objective information on fundraising in Ireland. It is intended to stimulate debate to encourage more detailed and transparent reporting of fundraising data.

Although empirical research is essential to identify best practice and to benchmark performance, trustees, CEOs, donors and civil society should bear in mind the diversity between organisations, which is not fully encompassed in this report. The report found that fundraised income rose 9% from 2016, increasing for the eighth consecutive year and accelerating significantly despite an ongoing struggle by the sector to improve public perceptions. This is indicative of the general trend that people trust people, not organisations. The total income generated from philanthropic sources amounted to ξ 1.1 billion in 2017, with the average cost to raise ξ 1 estimated at 24c. Ireland's giving per capita was ξ 233 in 2017, ξ 125 less than that of the U.K., narrowing the gap somewhat as per capita giving rises in Ireland and falls in the U.K., though when compared internationally, Ireland has substantial scope to develop its giving culture by looking to the U.K., New Zealand, and other societies with standardised philanthropic infrastructures.

The report notes that Ireland's tax treatment of charitable giving prevents the development of institutional philanthropy that is conducive to transformative giving. As the sector works to build public trust and improve negative perceptions, the ongoing discussions surrounding transparency and accountability are no longer enough: a mandatory, standardized system of reporting is crucial to creating sustainable growth. The sector must look beyond the organisational level and come together as advocates for policy change that will ease the burden of compliance and build a framework that encourages transparency, advancing the sector as a whole.
