## **ABOUT THE ROLE**

## **Role Summary**

The Director of Development will support the Foundation's Board of Directors in executing its long-term fundraising strategy.

The successful candidate will have responsibility for developing the Foundation's fundraising mix - growing streams of income from a diverse range of donors.

They will lead out on campaigns, cultivate and build relationships with an array of major donors, foundations, affiliated partners and corporate partners and play a key role in supporting the Foundation to achieve its mission.





## SPECIFIC RESPONSIBILITIES INCLUDE

## **Strategy and Strategic Development**

- Take overall responsibility for developing and executing a sustainable long-term donor fundraising strategy for generating and growing revenue to ensure the future growth of the Foundation.
- Monitor and evaluate fundraising activities against targets and maintain a clear and consistent reporting structure to the Board of Directors on progress.
- Keep abreast of developments in fundraising trends across the sector, be aware of current market and economic factors influencing fundraising activities and identify future trends and changes in opportunities and anticipate appropriate courses of action.
- Support the development, implementation and monitoring of strategic goals, objectives, and financial plans to meet both the short-term and long-term strategic plan aspirations.
- Champion the mission, vision and values of the Foundation and ensure that it has a focus on growth and development through continuous evaluation.
- Support the development and implementation of capital allocation frameworks to ensure the best return on investment across key metrics, including engagement, usage, inclusivity, sustainability and quality.





## **SPECIFIC RESPONSIBILITIES INCLUDE:**

### **Donor Engagement**

- Maintain, develop and grow relationships with corporate partners, donors, charitable foundations and government agencies through exceptional relationship management and a consistent level of face-to-face meetings with new prospects.
- Develop and manage a prospect list by collaborating with and growing the Foundation's network - identifying and building relationships with highnet-worth individuals and new corporate partners in Ireland and internationally; with a clear rationale as to why they will be approached.
- Identify key trusts, foundations and individual philanthropists, and establish how best to build their understanding of the purpose of the Foundation.
- Prepare and write creative and accurate fundraising proposals, donor prospectus and agreements, and any other materials needed to secure donations; and deliver compelling pitch presentations to prospective donors.
- Build a lead generation strategy and test new income streams ensuring a sustainable and diverse fundraising portfolio.
- Lead the planning, coordination, and delivery of fundraising events to strengthen donor relationships, enhance engagement and communicate the Foundation's mission and impact effectively.





## **SPECIFIC RESPONSIBILITIES INCLUDE:**

### **Stakeholder Engagement**

- Establish and develop excellent communication networks with key decision-makers and stakeholders in Ireland and internationally.
- Develop a close working relationship with the FAI, to understand the organisation and its
  requirements and ensure that the Foundation's fundraising case for support reflects the Facility
  Investment Vision and Strategy.
- Represent the Foundation with integrity, maintaining a professional standard in every engagement.
- Present at industry seminars / conferences when appropriate.

## **Finance, Governance and Reporting**

- Develop fundraising policies and procedures in line with necessary requirements.
- Develop and manage the fundraising budget.
- Build and maintain an effective working relationship with Board of Directors, ensuring open communication on the measurement of financial and impact performance against stated goals.
- Work with the Board of Directors to ensure that the Foundation is robustly governed to meet the highest levels of regulatory compliance.
- Supply regular reports to the Board of Directors and attend Board and sub-committee meetings; supporting the Board to make informed decisions.

## After 6 months in the role, you will be expected to be working towards the following priorities:

- ✓ Built strong and effective relationships with key stakeholders, including the Foundation Board of Directors and external partners.
- ✓ Led the development of a comprehensive fundraising strategy, created in consultation with the Board and aligned with organisational strategic priorities.
- ✓ Achieved measurable progress toward first-year fundraising and engagement targets.
- ✓ Implemented robust systems and processes to manage the fundraising pipeline, monitor performance, and strengthen relationships with existing and prospective donors.
- ✓ Supported the development of new policies and procedures to underpin operational establishment and the early stages of trading.
- ✓ Delivered a successful launch campaign, incorporating PR, communications, and event management components.
